Title: ENVIRONMENTAL TECHNICIAN (Part-Time)

Reports to: Chief Administrative Officer

Status: Non-Exempt – Part Time

Position Summary: The Environmental Technician works part-time and is responsible for interior and exterior (including yardwork) cleaning at the Greer Building and inside of the NCL clinic site. Work activities are planned with the lowest level of disturbance to areas providing patient care. The Environmental Technician is required to report any unusual occurrences or incidents to management immediately.

Responsibilities:

- Comply with Camillus Health Concern’s Mission, Vision, and Values and Compassionate Care Standards
- Maintains a consistently clean and safe environment for patients, visitors and employees
- Services all areas of the clinic, including offices, bathrooms and public areas, unless instructed to clean a specific area
- Monitors areas for trash and debris, remove and discard appropriately
- Operates blower, weed trimmer and other machinery to keep landscape free from leaves and debris
- Performs other duties as appropriate including moving and storing deliveries; completes basic maintenance including replacing light bulbs and other building repairs, performs light plumbing and light painting.
- Performs any other department or agency related duties or special projects as directed by Supervisor

Requirements:

- Use hands to lift, carry, push, or pull objects that may be heavy
- Have knowledge of procedures and techniques of cleaning and building maintenance/repairs
- Perform repetitive tasks daily
- Able to operate janitorial and landscaping equipment
- Minimum of one-year experience in janitorial/custodian work preferably in a health center or hospital environment.
- Able to follow instructions and directions to completion
- Comply with the facilities life safety code and health safety policy and procedures
- Must have transportation to go to and from sites
